1. On March 7, 1984, Lessee notified staff of the State Lands commission that a replacement line was needed for one of its authorized 8" production lines due to leaks caused by internal corrosion. The production lines serve Lessee's Platform Eva under State's Oil and Gas Leases PRC 3033 and 3413. The proposed activity was approved by the Coastal Commission on April 11, 1984. Technical details of construction were coordinated with State Land: Commission's engineering staff and installation of the new line was completed May 22, 1984. Due to technical and environmental concerns, removal of the old line is to be deferred until such time as all the lines would mormally be removed

(e.g., upon Lease termination). Lessee submitted "as built" plans and in some areas, the new 17,000±-foot line was installed outside the existing right-of-way. Lessee is now amending the Lease description to reflect the new pipeline use area and has requested that the volumetric rent lease language be removed from the lease. The old line is still included within the new lease description.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 1, Existing Facilities 2 Cal. Adm. Code 2905(a)(2).

Three strips of tide and submerged land 20 feet wide, in San Pedro Bay near Huntington Beach. Orange County, California, the centerlines of said strips being described as follows:

STRIP 1

BEGINNING at Union Oil Company's platform "Eva", said platform being located within State Oil and Gas Lease PRC 3033 and having California Zone 6 coordinates of X = 1,448,916 and Y = 548,783; thence across State Oil and Gas Leases PRC 3033, PRC 426, PRC 3177; and PRC 3119, N 1° 24' 13" W, 16,697 feet to a point having coordinates of X = 1,448,507 and and Y = 565,475; thence northwesterly 1,440 feet, more or less, through a spiral curve concave easterly and through a point having coordinates of X = 1,448,149 and Y = 566,033 to an intersection with a line that bears S 53° 30' W, from a point on the centerline of Warner Avenue, Orange County; thence N 53° 30! E, 218 feet along said line to a point that bears N 60° 03' 01" W, 201.57 feet from a CSLC brass cap monument in concrete designated "Los Patos 2, 1950", said monument having coordinates of X = 1,448,614.15 and Y = 566,794.72.

EXCEPTING THEREFROM in the southerry portion of said 20 foot strip any submerged land within State Oil and Gas Lease PRC 3033.

ALSO EXCEPTING THEREFROM any portion landward of the ordinary high water mark of San Pedro Bay in the northerly portion of said 20 foot strip.
