APPROVAL OF THE SUBSTITUTION OF A BLANKET BOND OF \$150,000 FOR THREE GEOTHERMAL LEASES TO REPLACE A \$500,000 BLANKET BOND COVERING LEASES WHICH HAVE EXPIRED OR BEEN CANCELLED

APPLICANT:

AREA, TYPE LAND AND LOCATION: Approximately 2,228 acres of reserved mineral land in the northwestern portion of The Cause

land in the northwestern portion of The Geysers Geothermal Field, Lake, Mendocino and Sonoma Counties.

BACKGROUND INFORMATION:

State Geothermal leases PRC's 5217, 5819, 5820, 5821, 6114, 5862, 5999, 6080 and 6081 were leased by competitive bidding between 1980 and 1982 to Aminoil USA, Inc. and later assigned to Geothermal Resources International (GRI) and its subsidiary GRI Exploration Corporation in 1983. State Lease PRC 5903 was issued to MSR Public Power Agency, assigned to Aminoil and then assigned to GRI. State Lease PRC 6421 was

issued by the Bureau of Land Management to Thermogenics, Inc., a subsidiary of GRI in 1974 and acquired by the State as an indemnity selection in 1983. The term of PRC 6421 expired in 1984.

In order to facilitate management of the leases, the Commission in January 1983 approved acceptance of a \$500,000 blanket bond for all eleven leases to replace the individual lease bonds.

On September 26, 1985, because of the lessee's failure to meet the drilling requirements of the lease, the Commission authorized cancellation of PRC's 5819, 6114, 5862, 5903, 5999, 6080 and 6081.

Because GRI now only holds three state leases, the firm has requested it be permitted to substitute a blanket bond of \$150,000 for PRC's 5217, 5820 and 5821 (Individual lease bond requirement is \$50,000) to replace the blanket bond. Since the number of leases to be covered by the blanket bond has been reduced, staff recommends acceptance of a blanket bond in the amount of \$150,000.

PREREQUISITES: The blanket bond for geothermal leases PRC 5217, 5280 and 5821 in the amount of \$150,000 has been submitted.

OTHER PERTINENT INFORMATION:

 Pursuant to the Commission's delegation of authority and the State CEQA Suidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.


