MODIFICATION OF STATE'S RIGHT OF SURFACE ENTRY

APPLICANT:

Southern California Edison Company

P. O. Box 410

Long Beach, California 90801

AREA, TYPE LAND AND LOCATION:

A portion of the NW: 1/4 of Section 16, T9N R1W, SBM, totaling 10.101 acres. The school land parcel was patented in 1948 with a 100 percent mineral reservation to the State and is situated within the city limits of Barstow in San Bernardino County.

PERTINENT INFORMATION:

- 1. The surface owner, Southern California Edison, acquired the property in March 1975 and constructed a combined service facility consisting of an office building, warehouse, garage and service yard to provide electrical service to the Barstow area. Edison has requested the State to modify its right of surface entry to a depth of 500 feet in order that the property qualify to be included in its Trust Identure and be a bondable asset.
- 2. Section 6401(b) of the Public Resources Code provides in part that... "upon a finding by the commission that there are no known deposits of commercially valuable minerals in and above a plane located 500 feet below the surface of any land sold...and wherein any...of the mineral deposits... are required by law to be reserved to the State, the Commission may

by... appropriate instrument, modify the accompanying rights of the State to the use of the surface of such lands, including any right to enter such lands to a depth of 500 feet below the surface of such lands, as will permit the orderly use and development of all such sold or exchanged lands."

- 3. A geologic study completed by Southern California Edison Company, reports that the subject parcel does not contain commercially valuable mineralization. Further, an independent study made by the State Lands Commission's staff concurs with that finding.
- 4. Pursuant to the Commission's Guidelines (14 Cal. Adm. Code 15061) the staff has determined that this activity is exempt from the requirements of the CEQA because it is not a "project" as defined by CEQA and State CEQA guidelines.
- 5. The applicant has submitted the required filing fee and expense deposit.
