APPROVAL OF A NON-EXCLUSIVE GEOLOGIC SURVEY PERMIT ON TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION

PROPOSED AUTHORIZATION:

Approval of a Non-Exclusive Geologic Permit for three years to conduct geologic surveys on tide and submerged lands under the ownership and jurisdiction of the State Lands Commission, out to the three-mile limit, within permit regions I, II, III and IV as depicted on

Exhibit "A" hereto.

TERM:

The term of the Non-Exclusive Geologic Survey permit is three years.

PROJECT:

The geologic surveys authorized under the terms of the permit are for the purpose of obtaining shallow samples of the seafloor for geotechnical information. The datá obtained is used in the design of offshore structures (pipelines, marine terminals, platforms, etc.) and in the technical and environmental analyses of offshore oil and gas operations. shallow samples are obtained using nonrotary techniques (dart, jet, percussion, grab) from an anchored self-contained vessel. The vessel is typically no larger (50 to 150 feet in length, 6 foot draft) than fishing boats used in the Santa Barbara Channel.
