ACCEPTANCE OF RENTAL FOR TIDE AND SUBMERGED LANDS PREVIOUSLY INCLUDED IN LEASES PRC 4193 AND PRC 4626

PROPOSED CONSIDERATION: \$7,840, CALCULATED AS FOLLOWS:

A negotiated rental of \$1,500 per annum for tide and submerged lands previously included in PRC 4193, prorated for the period November 20, 1980 through December 31, 1985; and a negotiated rental of \$1,500 per annum for the tide and submerged lands previously included in PRC 4626, prorated for the period November 20, 1985 through December 31, 1985.

Applicant is lessee of upland.

OTHER PERTINENT INFORMATION:

1. Lease PRC 4193 at Jewfish Point expired on November 19, 1980. In the process of negotiating a new lease with Connolly-Pacific, the staff discovered that tide and submerged lands had been filled at Jewfish Point and Empire Landing as well as at other sites at Santa Catalina Island. There is a dispute as to the extent and ownership of these filled lands between the State and the Santa Catalina Island Company, owner of the adjacent upland, from whom Connolly-Pacific leases the quarry site. Lease PRC 4626 at Empire Landing expired November 19, 1985.

CALENDAR ITEM NO. 15 (CONT'D)

In addition, the City of Avalon and County of Los Angeles have been conducting a feasibility study for construction of a commercial airport on the island which included consideration of Jewfish Point as a possible site. The scaff has been informed that the City does not plan further consideration of Jewfish Point as an airport site.

- Processing a lease for Connolly-Pacific has been held in abeyance during the title and boundary studies and determination by the City and County of airport site feasibility.
- 3. This negotiated rental covers use of the sites under PRC 4193 from November 20, 1980 through December 31, 1985 and older PRC 4626 from November 20, 1985 through December 31, 1985. Beginning January 1, 1986 the two Leases will be combined into one new lease which is being negotiated and will be considered in another Commission action.
- 4. Because delays in processing a new lease for the moorings have been due to title and boundary disputes between the State and the Santa Catalina Island Company, the staff recommends that penalty and interest be waived on rental for the period through December 31, 1985.
- 5. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because there is no possibility that this activity may have a significant effect on the environment.

AUTHORIZE ACCEPTANCE OF \$7,840 FROM CONNOLLY-PACIFIC COMPANY AS CONSIDERATION: FOR THE USE OF SITES PREVIOUSLY LEASED UNDER PRC 4193 FROM NOVEMBER 20, 1980 THROUGH DECEMBER 31, 1985 AND UNDER PRC 4626 FROM NOVEMBER 20, 1985 THROUGH DECEMBER 31, 1985 FOR MAINTENANCE OF SIX MOORING BUOYS FOR USE AS BARGE AND TUGBOAT TIE-UPS ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
- 4. WAIVE PENALTY AND INTEREST ON RENTAL FOR THE ABOVE PERIODS.

A circular parcel of submerged land 164 feet in diameter, the center of said circle having coordinates of N=3,862,730 and E=4,197,210.


