ANNEXATION OF SUBMERGED LANDS, CITY OF CHULA VISTA, SAN DIEGO COUNTY

The State Lands Commission has received a request from County of San Diego, LAFCO to review and approve the boundaries for annexation of the proposed Palomar/Bay Boulevard Reorganization (No. 85-22).

This area includes approximately 63 acres, more or less, of land including areas within the historic bed of San Diego Bay. The area proposed for annexation is located westerly of areas previously annexed by Chula Vista and involves a one-half mile long parcel lying along San Diego Bay to be deannexed from the City of San Diego and annexed to Chula Vista.

Pursuant to Government Code Section 36108, the Commission is to review and approve or deny the proposed annexation boundaries as appropriate and correct.

The staff of the Commission has reviewed the proposed annexation boundary description and finds it adequate. Furthermore, staff has no objection to transfer of local police power jurisdiction from the City of San Diego to the City of Chula Vista and, therefore, submits the recommendations of approval below.

#### LAND DESCRIPTION


- Thence along said mean high tide line as follows:


- 6. Thence S 00 47' W. 400.00 feet along said westerly line to the southerly boundary of said Rancho de la Nacion;
