APPLICANT:

Donald Kennedy and Betty Lawrence 10 West Mossdale Road, #4 Lathrop, California 95330

AREA, TYPE LAND AND LOCATION: A G.O25-acre parcel of tide and submerged land, located in the San Joaquin River at Mossdale Trailer Park, San Joaquin County.

LAND USE: Construction and maintenance of a floating dock and ramp.

TERMS OF PROPOSED PERMIT: Initial period:

Ten years beginning December 1, 1985.

Public liability insurance: Combined single limit coverage of \$100,000 per occurrence for bodily injury and property damage.
