OTHER PERTINENT INFORMATION:

 Staff recommends approval of a license to the applicant to enter onto the Pacific Coast Beaches below mean high tide in Humboldt and Del Norte counties, for collection of driftwood and redwood to create furniture and gift items. This license will give the applicant non-exclusive use of the lands as described in Exhibit "A" for the stated purpose only.

The applicant requested the license because the local law enforcement agencies strictly enforce the law covering transportation of forest products pursuant to Section 384.5 of the California State Penal Code. As a condition of the license, the applicant agrees to use only public access designated as such to gain entrance to State lands.

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 4, Minor Alteration to Land and Water, 14 Cal. Adm. Code 15304.

Authority: P.R.C. 21084 and 14 Cal. Adm. Code 15300.

3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

EXHIBIT "A"

LAND DESCRIPTION

WP 6615

A strip of tide and submerged land 50 feet wide in the Pacific Ocean, Del Norte and Humboldt Counties, California, bounded as follows:

- 1. On the south by a line extending due east from False Cape Rock.
- 2. On the north by the California-Oregon border.
- 3. On the east by the mean high tide line of the Pacific Ocean.
- 4. On the west by a line parallel with and 50 feet seaward from said mean high tide line.

EXCEPTING THEREFROM the areas included within all City, County, State, or Federal Beachs, parks, or granted tidelands.
