AUTHORIZATION TO ACCEPT A QUITCLAIM DEED FOR GEOTHERMAL LEASE PRC 6398 THE GEYSERS, MENDOCINO COUNTY

APPLICATION:

M-S-R Public Power Agency

AREA, TYPE LAND AND LOCATION:

Approximately a 320-acre parcel of school lands in the north half, Section 28, T12N R9W, MDM,

Mendocino County.

BACKGROUND INFORMATION:

On March 24, 1983 the State Lands Commission approved the issuance to M-S-R Public Power Agency of a geothermal lease by competitive public bid in the northwest portion of the Geysers Geothermal Field, Mendocino County.

The lease was for a primary term of ten years, in addition to paying a royalty of 12.5 percent of the gross revenue received, the Lessee also agreed to pay 12 percent of the net profits derived from the lease.

Other terms of the Lease required that the Lessee:

- Drill an exploratory well to evaluate the geothermal resources within three years of the lease issue date (March 24, 1983).
- Submit annually a plan of development and operation.

CALENDAR ITEM NO. 27 -(CONT'D)

The Lessee did not will an exploratory well or file an application to drill a well. M-S-R also did not file an annual plan of operations and development as required under the lease.

On March 6, 1986, a representative of SAI Geothermal, Inc. was present to testify in favor of an extension of the drill-by date for PRC 6398, but the request was denied.

On March 27, 1986, the Commission approved the staff recommendation authorizing notification of default and the notice was mailed March 27. On May 29, 1986, the Commission authorized cancellation of lease. M-S-R has now submitted a quitclaim deed for PRC 6393 and staff recommends acceptance.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA guidelines.
