OTHER PERTINENT INFORMATION:

1. At its meeting on May 26, 1977, the State Land's Commission, in Minute Item 9, approved the issuance of General Permit — Recreational Use PRC 5300 to Bay Cities Refuse Service, Inc. for the purpose of construction of the pier.

The permittee subsequently conveyed the upland to applicant without first receiving the Commission's approval of the assignment, transference or subletting of said permit. As the permit will expire March 31, 1987, and the format of this agreement is not consistent with the Commission's current rules and regulations, termination of this permit is recommended.

2. As to the termination of the current general permit, pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15001), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority P.R.C. 21065 and 14 Cal. Adm. Code 15373.

3. As to the issuance of the new general permit, Pursuant to the Commission's delegation of authority and the State CteA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 1, Existing Facilities, 2 Cal. Adm. Code 2905(a)(2).

Authority: P.R.C. 21084, 14 Cal. Adm. Code 15300, and 2 Cal. Adm. Code 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. - 1. AS TO THE TERMINATION OF THE CURRENT GENERAL PERMIT PRC 5300, FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 BECAUSE THE ACTIVITY IS NOT A PROJECT AS DEFINED BY P'R.C. 27065 AND 14 CAL. ADM. CODE 15378.
- 2. AS TO THE ISSUANCE OF THE NEW GENERAL PERMIT, FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 AS A CATEGORICAL EXEMPT PROJECT, CLASS 1, EXISTING FACILITIES, 2 CAL. ADM. CODE 2905(a)(2).
- 3. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.
- 4. AUTHORIZE TERMINATION OF GENERAL PERMIT RECREATIONAL USE PRC 5300 DATED JUNE 9, 1977, EFFECTIVE APRIL 14, 1986; AND THE ISSUANCE TO BAY VIEW REFUSE SERVICE, INC. OF A 15-YEAR GENERAL PERMIT RECREATIONAL USE BEGINNING APRIL 14, 1986; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$215, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE PERMIT; WITH PROVISION OF A \$2,000 SURETY BOND; AND WITH PROVISION OF PUBLIC LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$500,000; FOR MAINTENANCE OF AN EXISTING PIER ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

A parcel of land in the bed of Lake Tahoe, adjacent to fragitional Section 7, T14N, R17E, MDM, and near Tahoma, Placer County, California, more particularly described as follows:

All that land lying immediately beneath and extending 10 feet from all sides of a pier, adjacent to Lot 17. Moana Beach, as said Lot is shown on the map filed in Book "H" of maps at page 7, Placer County Records.

EXCEPTING THEREFROM any portion lying landward of the ordinary low water mark.
