APPROVE THE EXECUTION AND RECORDATION OF MEMORANDUM OF AGREEMENT

PARTIES:

Signal Bolsa Corporation

Signal Landmark, Inc.

California Department of Fish and Game

California State Lands Commission

The State and Signal are parties to the 1973 Boundary Settlement and Exchange Agreement (BLA 137) regarding lands in the Bolsa Chica Area, Orange County, dated January 25, 1973.

On May 31, 1983 the Commission approved an amendment to the original 1973 Agreement authorizing the extension of the lease and option period for three years. The option expired August 17, 1986.

The State, Orange County, Signal and other interested parties have been involved in the preparation and approval of a Local Coastal Program for the subject area as well as encouraging the completion of the United States Army Corps of Engineers Sunset Harbor Study. While these processes are still continuing — progress has been made. In order to provide additional time in which to complete these processes and obtain an appropriation to complete an ocean entrance channel an extension of the option period is essential. Therefore, the parties wish to further extend the option period in which to obtain an appropriation to April 17, 1987.



## MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT is entered into as of the day of \_\_\_\_\_\_, 1986 by and among the California State Lands Commission, California Department of Fish and Game (hereinafter collectively referred to as "Lessees"), Signal Bolsa Corporation and Signal Landmark, Inc. (hereinafter collectively referred to as "Signal").

- 1. Signal and the State of California acting by and through Lessee State Lands Commission entered into a Boundary Settlement and Exchange Agreement dated January 25, 1973, an element of which included a Lease of Right of User and Option to Acquire Real Property ("Lease/Option"), the date of recordation and effective date of which was August 17, 1973. The term of the Lease is for a period of fourteen (14) years commencing on said effective date.
- 2. Paragraph 3 of the Lease/Option grants to Lessee State Lands Commission the exclusive right and option to acquire ("Option") all of Signal's right, title and interest in and to the lands subject to the Lease/Option upon the satisfaction of certain conditions. Paragraph 3(c) of the Lease/Option requires

CALENDAR PAGE 93.3 MINUTE PAGE 3882 Lessee State Lands Commission to obtain within ten (10) years from the Effective Date of the Lease/Option, an "Appropriation" as that term is defined in Section 1.1 of the Boundary Settlement and Land Exchange Agreement Régarding Lands in the Bolsa Chica Area, Orange County, California, dated January 25, 1973 ("Settlement Agreement") for the purposes of completing the Ocean Entrance System as that term is defined in the Settlement Agreement. Under the terms of the Lease/Option, the Option was to have expired on August 17, 1983.

- 3. On August 15, 1983, the parties hereto entered into and recorded on August 16, 1983 in the Official Records of Orange County, California, as No. 83-355937 a Memorandum of Agreement as evidence and notice of the agreement to amend the Lease/Option by extending the period in which Lessees may obtain an Appropriation by three (3) years. The Option, as amended, expired on August 17, 1986.
- 4. For and in consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby amend the Lease/Option by extending the time permitted for Lessees to obtain an Appropriation from August 17, 1986 until April 17, 1987.
- 5. It is the intent of all of the parties that nothing in this Memorandum of Agreement shall affect any other provision or term set forth in the Lease/Option or Settlement Agreement which Shall continue in full force and effect.

IN WITNESS WHEREOF, the undersigned being duly authorized to sign on behalf of their respective agencies, hereby execute this Memorandum of Agreement, effective as of the date first set forth above.
