SEVENTH MODIFICATION OF THE 1986-87
PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET
LONG BEACH UNIT, WILMINGTON OIL FIELD
LOS ANGELES COUNTY

The City of Long Beach has submitted to the Commission the Seventh Modification of the 1986-87 Plan of Development and Operations and Budget, Long Beach Unit. The Seventh Modification would modify the Plan to provide for additional computer capacity and fund the equipment by transfer of funds. The total adjusted budget would remain unchanged at \$137,135,000.

Purchase of three micro computers and graphic display and peripheral equipment is anticipated at a total cost of \$350,000.

With recent advances in computer technology and software, oil reservoir simulation for reservoirs as complex as those in the Long Beach Unit has become economically possible and is currently being done. The Unit does not have the equipment for graphic presentation of the reservoir simulation output or to run "what if" cases for reservoir management studies.

Surplus funds are available in the Drilling and Development Program under Development Drilling.
