APPROVAL OF SPECIFICATIONS AND FORMS FOR INVITING BIDS FOR CRUDE OIL FROM FAULT BLOCK IV UNIT AND FAULT BLOCK V RANGER ZONE UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY, BY THE CITY OF LONG BEACH

Since 1977, the City of Long Beach has had a crude oil sales contract with Petrominerals Corporation for the oil allocated to the City from certain tracts (listed in Exhibit "A") within the Fault Block IV Unit and Fault Block V Ranger Zone Unit. Due to the world-wide decline in crude oil prices over the past year, Petrominerals Corporation has given the City the required one-year notice of termination so that this contract with the City will terminate on May 1, 1987. Petrominerals Corporation was paying the City for this oil the average of posted prices in the Wilmington Oil Field among the postings of Chevron U.S.A. Inc.; Union Oil Company of California; Texaco Inc; Mobil Oil Corporation and ARCO Petroleum Products Company until ARCO stopped posting.

In addition, the City has a crude oil sales contract with MacMillan Ring Free Oil Company for the oil from Tract Number 20 of the Fault Block IV Unit and Tract Number 92 of the Fault Block V Ranger Zone Unit as noted in Exhibit "B". This contract commenced on June 1, 1986 and will terminate on June 1, 1987. MacMillan is paying the City \$1.959 per barrel <u>below</u> the highest price posted for like crude oil on the day of delivery in the Wilmington, Long Beach (Signal Hill), Huntington Reach and Inglewood Oil Fields among the postings of Chevron, Mobil, Union and Texaco.

The City's share of crude oil from these tracts amounts to approximately 200 barrels per day of 170 API gravity crude oil. The City's interests are working interests, so the oil cannot be returned to a lessee or contractor. Therefore, the

City must sell the oil at this time. To reduce costs, the two crude oil sales contracts will be combined so that one crude oil sell-off will be held.

Under Section 10(a) of Chapter 29, Statutes of 1950, 1st E.S., the specifications and forms for the purpose of inviting bids for the sale of Long Beach tidelands crude oil must be approved by the State Lands Commission prior to publication of the notice to bidders. The City plans to hold a bid opening on March 4, 1987. The Commission must then approve the awarding

SPECIFICATIONS OF SALE OF CRUDE OIL PRODUCED FROM FAULT BLOCK IV UNIT AND FAULT BLOCK V RANGER ZONE UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY

1. Volume

The oil will be 100% of the City's working interest share of crude oil produced from tracts within the Fault Block IV Unit and Fault Block V Ranger Zone Unit, Wilmington Oil Fixed, Los Angeles County. This is approximately 200 barrels per day of 17° API gravity crude oil.

2. Price

The biddable factor will be a bonus bid per barrel above the Bass Price defined as the highest price posted for like crude oil on the day of delivery in the Wilmington, Long Beach (Signal Hill), Huntington Beach and Inglewood Oil Fields among the postings of Chevron USA, Mobil Oil Corporation and Union Oil Company of California.

3. Term

The contract will be for a term of 12 months commencing May 1, 1987 and expiring on May 1, 1988. Deliveries from some tracts will not begin until June 1, 1987.

4. Surety
