GENERAL PERMIT - PUBLIC AGENCY

APPLICANT:

San Diego Water Utilities Department

BACKGROUND:

At its December 23, 1986 meeting, the Commission authorized issuance of a 25-year General Permit - Public Agency Use to the City of San Diego Water Utilities Department covering an existing treated sewage outfall line at Point Loma in San Diego. The outfall line has been in existence since 1961.

Subsequent to Commission authorization and prior to final execution of the General Permit, the Water Utilities Department requests approval of an option to renew the Permit for an additional 24 years. Said renewal could only be exercised after 90 days written notice by the permittee and upon approval by the Commission. The renewal option is desired by the City of San Diego to provide assurance of site availability throughout the functional life of their outfall facility.

Staff has considered the City's request and recommends the Commission amend its prior authorization to include the renewal option as included in the proposed General Permit - Public Agency Use, incorporated herein and on file with the staff of the Commission. All other terms and conditions of the Permit will remain unchanged.
