1. At its meeting of August 25, 1977, the State Lands Commission, in Minute Item 5, approved the issuance of General Permit — Recreational Use PRC 5373 to Stockton Water Ski Club for a term of ten years beginning March 1, 1977, with renewal options of two successive periods of ten years each. The format of this agreement is not consistent with the Commission's current rules and regulations. Therefore, termination of this permit is recommended.

Applicant is a non-profit California corporation incorporated to promote social activities among, and recreational facilities to, its members.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 1, Existing Facilities, 2 Cal. Adm. Code 2905(a)(2).
