

OTHER PERTINENT INFORMATION:

 Uhen the permit was originally negotiated, the District carried umbrella insurance coverage of \$5 million. However, due to spiralling insurance costs, the District has been forced to reduce coverage to \$2.5 million. They request that the Commission accept the reduced amount to fulfill the combined single limit public liability insurance requirement.

Staff believes the original required amount was excessive in relation to risk and recommends approval of the modification.

2. Pursuant to the Commission's delegation of authority and the State CECA Guidelines (14 Cal. Adm. Code 15051), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines:
