however, during this interim, conditions and circumstances in the insurance industry changed considerably, preventing issuance of the lease. The proposed Lessee and her agent have for a number of months diligently tried to acquire the public liability insurance coverage required by the Commission, without success. Naomie King has been successful only in finding and providing a certificate of insurance for \$300,000 combined single limit coverage and requests that the Commission accept the reduced amount to fulfill the coverage originally required.

Through her agent, Naomie King also has told staff she is unable to provide the necessary recreational boating facilities without the authorized lease for her tenants, lessees and guests.

Staff believes that Mrs. King has made a diligent and conscientious effort to provide the initial required insurance. Staff, therefore, recommends approval of the reduction.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.
