APPROVAL OF MANAGEMENT PLAN AND AUTHORIZATION FOR THE CALIFORNIA DEPARTMENT OF FORESTRY TO PROCEED WITH FOREST DEMONSTRATION PROJECT ON A PARCEL OF

STATE SCHOOL LAND IN SHASTA COUNTY

BACKGROUND INFORMATION:

The interagency agr ement under which certain school lands are managed by the California Department of Forestry requires submittal of management plans for Commission approval and authorization to proceed with projects on specific parcels. This parcel is adjacent to a parcel which is already under CDF management at Summit City in Shasta County. The parcel currently under management has been used to demonstrate planting techniques and survival and growth rates of native and introduced tree species. CDF feels that the initial results are very promising for this area in the "tension zone" between the chaparral and low elevation conifer vegetation types and would like to expand into the adjacent parcel to thy some new species and corroborate initial successes in the existing parcel.

Staff has reviewed the management plan and concluded that it is in keeping with the objectives sought in the interagency agreement.



### SUMMARY

Through an interagency agreement, dated July 1, 1980, between the State Lands Commission (SLC) and the Californs' Department of Forestry (CDF), ODF was authorized to conduct management of the surface resources of ten State School Lands parcels located in Shasta, Trinity, and Lake Counties. Under the terms of the agreement, CDF will manage the parcels for: 1) experimentation, 2) demonstration of sound and innovative forest management techniques to small private owners, and 3) acceleration of the sale and harvesting of merchantable timber from the parcels. As part of the project, the full range of approved California Forest Improvement Program (CFIP) practices would be incorporated, as appropriate to the parcels. In 1982, CDF prepared, circulated, and adopted an EIR for the project (SCH #181082617). Road construction, timber harvesting, site preparation, planting, timber stand improvement, brush conversion, forest land conservation measures, wildlife habitat improvement, and fuel reduction have been accomplished on various parcels to date.

Five additional parcels, located in Alpine, Lake, Trinity, and Tulare Counties were included in the program in 1985. These parcels ranged in size from 40 acres to 160 acres. A Supplement to the EIR was prepared pursuant to Section 15163 of the State EIR Guideline based upon the rationale that the addition of the five parcels did not materially alter the program goals. Additional acreage in Summit City, Shasta County, is being included in the program as a supplement to the original EIR. The unit is adjacent to the original Summit City parcel. The addition of this unit does not alter the program's goals or objectives, but allows for an expansion of current projects. Specific

CALENDAR PAGE 159 MINUTE PAGE 1962 activities planned on the annex parcel include brush clearing, establishment of eucalyptus plantations for biomass production, and other off-site and exotic tree species for erosion control studies.

## ENVIRONMENTAL SETTING

## Location

The Summit City Annex parcel is located 7 miles north of Redding. The legal description is a portion of the NW1/4 NW1/4 Section 25 and portions of the N1/2 NE1/4 and portions of the WE1/4 NW1/4 Section 26 T33N R5W MDB&M. The parcel is partitioned into three (4) units as per Shasta County Assessor's Map Book 6, page 73. Unit 2 consists of 3.6 acres, unit 14 is 18.52 acres, and unit 15 is 114.55 acres in size for a total of 136.68 acres.

### Climate

The Summit City area can be represented as a Mediterranean climate. Summers are hot and dry with temperatures regularly exceeding 100 (F. Precipitation normally falls during the winter months from October to April. It is generally in the form of rain with an occasional snowfall. Extended cold spells with temperatures below freezing can occur, but they seldom drop below 25 F.

## Topography

The elevation ranges from 920 to 1,120 feet. Slopes vary from Q to 45 percent with the average being 20 percent. The predominant aspect is south.

### Water Resources

The east end of the parcel contrins a Class I stream. All other

plant, settling ponds, six water lines, and a water storage tank, all managed by the Shasta Dam Public Utilities District.

## Archeological and Cultural Resources

A records search revealed no known sites in the project area. A field inspection of selected areas was conducted without locating any significant sites. A follow-up survey will be completed after the brush removal is completed.

## Mitigation Measures and CEQA Compliance

A natural vegetation buffer strip of 50' (feet) will be left around the perimeter of the parcel. This will minimize visual impact to the area as the parcel is situated at the intersection of the two main access roads for Shasta Dam.


No management activities will occur within the confines of the class I drainage in the east end of the unit.
