ANNEXATION OF TIDE AND SUBMERGED LANDS, CITY OF LAGUNA BEACH, ORANGE COUNTY

APPLICANT:

City of Laguna Beach Attn: Rob Clark Deputy City Manager 505 Fores: Avenue Laguna Beach, California 92651

The State Lands Commission has received a request from the City of Laguna Beach to review and approve the boundaries for annexation of the proposed South Laguna Annexation.

This area includes approximately 12.5 square miles of which more than 82% is tide and submerged lands of the State lying within the three-mile offshore area. The area proposed for annexation is located southerly and westerly of areas previously annexed by Laguna Beach and involves an approximate three-mile shoreline.

In a review of Commission files, staff has determined that a portion of the presently proposed annexation area was involved in a prior Commission annexation approval pursuant to Item No. 38 of the October 30, 1981 meeting.

In order to clarify the status of that approval and in order to prevent future uncertainty, staff of the Commission believes the Commission should determine that its prior action and approval involving the area has expired and limit any future approval period to a term of one year, during which any proposed annexation, which, if approved by the Commission, must be finalized.


