AUTHORIZATION FOR PREPARATION AND PROCESSING OF A STATE PATENT TO BE ISSUED TO FRIEDRICH WEINSDORFER

Friedrich Weinsdorfer purchased 200 acres of school land in Humboldt County on October 2, 1899, and a fully paid Certificate of Purchase was issued on April 27, 1900. Mr. Weinsdorfer was entitled to a State patent, but he never obtained one.

The original Certificate of Purchase is beyond the control of the current land owners, Frances Doyle. Donald Etter, Keith Etter and Mary Etter. To assist in completing a chain of title to the current owners, a patent needs to be issued in the name of Friedrich Weinsdorfer, the original purchaser.

Staff has examined the file and other information submitted by the current owners and has concluded that the laws relating to issuance of a patent have been complied with, and that the person to be named in the patent, Friedrich Weinsdorfer, is entitled to it.
