BACKGROUND

- 1. The Commission approved a one-year proposed lease at its November 20, 1986 meeting for the temporary mooring of the Riverboat "Delta King" at the existing River Lines Pier, including some limited pier use.
- 2. On February 9, 1987, a portion of the Sacramento River floodwall under the River Lines Pier collapsed along with a portion of the adjacent pier. With concern for the safety of the Riverboat "Delta King" and fearing further pier collapse, the owners moved the riverboat upstream to the City's "Old Sacramento" lease area on February 11, 1987.

Although the riverboat was moved, Riverboat Delta King, Inc., continued to use a portion of the River Lines Pier, until approximately early August 1987, for storage of riverboat materials.

CALENDAR ITEM NO. C17 (CONT'D)

CURRENT SITUATION:

- Although they have not returned a signed lease, the Riverboat Delta King, Inc. has paid the full monthly rent up to the time the riverboat was moved.
- 4. The approved, but unsigned lease, provides that:

"This agreement may be terminated by either the Lessee or the Lessor by giving 30-day's written notice to other party. This supersedes the notice term specified in Panagraph 12 of Section 4."

Notice to terminate this lease on August 3, 1987 was provided by letter dated June 17, 1987.

- 5. The City of Sacramento has let a contract for the demolition of the River Lines Pier and the reconstruction of the floodwall.
- This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.
- 7. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

- 4. TERMINATE THE LEASE AUTHORIZED BY THE COMMISSION AT ITS MEETING OF NOVEMBER 20, 1986, OR ANY OTHER TENANCY EFFECTIVE AUGUST 4, 1987, AND AUTHORIZE RELEASE OF THE \$5,000 SURETY BOND.
