OTHER PERTINENT INFORMATION:

The remains of a significant wreckage were 1. initially identified by side-scan sonar and a diving survey which was conducted in 1986. Archaeologists have determined the ocean-going sailing vessel to be associated The possibility with the Gold Rush Days. exists that it will be identified as the La Grange, a vessel with a colorful history including utilization as a prison ship. The Applicants are hopeful that through this study, the wreckage can be positively identified. From the information provided by the Applicant pursuant to application processing, staff understands that DPR intends to evaluate and identify the vessel only. Any artifact sampling will be solely for diagnostic purposes to answer basic research questions. Because finances are limited, selective sampling is anticipated to maximize research effectiveness. lies within the proposed Old Sacramento National Register Historic District.

DPR is developing plans to create a parkway on their upland property as part of the total waterfront redevelopment project. This study is considered essential mitigation to that project as the artifacts may be adversely affected by the waterfront development project.

- 2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
