ASSIGNMENT AND DEFERMENT OF DRILLING OPERATIONS STATE OIL AND GAS LEASE PRC 3499

ASSIGNOR:

AREA, TYPE LAND AND LOCATION:

State oil and gas lease PRC 3499 contains approximately 1,340 acres of submerged lands located immediately south of State oil and gas leases PRC 2879 and PRC 2207 (quitclaimed July 25, 1975) and three miles south of Government Point, at the western end of the Santa Barbara Channel, Santa Barbara County (see Exhibit "A").

### LEASE INFORMATION:

State oil and gas lease PRC 3499 was originally issued to Phillips Petroleum Company (Phillips) (50 percent) and Pan Petroleum Company, Inc. (now Amoco Production Company) (50 percent) on June 15. 1966. The lease contains a continuous drilling obligation interruptible for periods not to exceed 120 days between wells.

### BACKGROUND OF ASSIGNMENT:

Phillips, who is operator of the lease, and Exxon have reached agreement on the assignment of all of Phillips' 50 percent interest in State Oil and gas lease PRC 3499, and Exxon, who will also be the operator of the lease, has requested that the State Lands Commission consent to the assignment of this portion of the lease.

#### PREREQUISITE ITEMS:

- A. Assignment forms have been executed by Phillips and Exxon and are on file in the Long Beach office of the Commission.
- B. Exxon is qualified to hold State leases.
- Filing fee and processing costs have been received.

#### BACKGROUND ON DEFERMENT:

Exxon, as operator of the lease, has requested a deferment of the drilling obligation of State oil and gas lease PRC 3499 until September 30, 1988. This deferment will allow Exxon sufficient time to evaluate and finalize exploration plans and to prepare and file documents necessary to permit exploratory drilling.

On February 23, 1984, the State Lands Commission authorized the resumption of offshore exploratory drilling operations on State oil and gas lease PRC 3499. Under this authorization, the lessee was required to commence drilling by August 23, 1984. A defigurent was granted to January 1, 1986, pending recript of a Santa Barbara County APCD permit. Phillips had started negotiating with the Sarta Barbara County APCD in January 1984, regarding the pollutants to be monitored. Actual data collection in the field began in April 1985. Phillips applied in July 1986 to the County for an authority to construct. The Santa Barbara County APCD advised Phillips that the exploratory drilling project air data was being reevaluated. This reevaluation was concluded in November 1986, and the County informed Phillips that the County would accept an application for an authority to construct.

Phillips, in the meantime, was reprocessing geophysical seismic data to define better the geologic structure to be drilled. The reprocessing of data and analysis required three or four months to complete. The State Lands Commission, on March 26, 1987, granted a deferment of the drilling obligation until September 30, 1987.


