BACKGROUND:

At its meeting on October 23, 1986, the State Lands Commission awarded the Royalty Oil Sales Contract for State Oil and Gas Lease PRC 3120, South Ellwood Offshore Field, Santa Barbara County, to Huntway Refining Company for a period from April 1, 1987 to October 1, 1988. Huntway Refining Company was the highest responsible bidder for the competitively bid contract, offering to pay the State a bonus of \$0.285 per barrel about the Base Price. Base Price is defined as the highest price posted for oil of like gravity and quality on the day of delivery in the Ellwood Oil Field and South Ellwood Offshore Field among the postings of Cheuron USA, Inc. and Mobil Oil The State's share of production from this lease is approximately 26,000 barrels Corporation. per month of 21.00 API gravity crude oil.

At its meeting on November 20, 1986, the State Lands Commission awarded the Royalty Oil Sales Contract for State Oil and Gas Lease PRC 3242, South Ellwood Offshore Field, Santa Barbara County to Huntway Refining Company for a period County to Huntway Refining Company for a period From June 1, 1987 to December 1, 1988. Huntway Refining Company was the highest responsible bidder for the competitively bid contract, offering to pay the State a bonus of \$0.22 per barrel above the Base Price. The Base Price barrel above the Base Price. The Base Price of 1 Sales Contract. The State's share of 1 Sales Contract. The State's share of 1 production from this lease is approximately 44,000 barrels per month of 21.00 API gravity crude oil.

PERTINENT INFORMATION:

On August 25, 1987, staff received a letter from Mr. Juan Forster of Huntway Refining Company advising that effective September 1, 1987, Huntway Refining Company, a California limited partnership, is being dissolved and superseded by Huntway Refining Company, a new Delaware limited partnership. Huntway will submit, as necessary, riders for the insurance certificates and letters of credit required by certificates and letters of credit required by both Royalty Oil Sales Contracts. It also has completed assignment forms as requested by staff counsel under Section 10 of the Royalty Oil Sales Contracts.

Staff recomends that the Commission approve the assignment of these contracts on the conditions that the assignor shall not be released from any obligations arising before the effective date of the assignment and that the assignee shall be bound by the terms of the contract to shall be bound by the assignor, any conditions the same extent as the assignor, any conditions in the assignment agreement to the contrary notwithstanding.
