AWARD OF THE ROYALTY OIL SALES CONTRACT, STATE OIL AND GAS LEASES PRC 425, PRC 91NU AND PRC 91MZU, HUNTINGTON BEACH FIELD, ORANGE COUNTY.

On August 20, 1987, the State Lands Commission authorized the sale of royalty crude oil from several State oil and gas leases, including State Oil and Gas Leases PRC 425, PRC 91NU and PRC 91MZU, Huntington Beach Field, Orange County.

Caljet, Inc. is presently purchasing the State's share of crude oil produced from these leases. Caljet pays the State a bonus of \$0.5459 per barrel above a base price defined as the highest price posted for oil of like quality and gravity in the Huntington Beach Field on the day of delivery among the Huntings of Chevron USA Inc., Mobil Oil Corporation and Union postings of Chevron USA Inc., Mobil Oil Corporation and Union Oil Company of California. The State's share of production Oil Company of California. The State's share of production from these leases is approximately 15,000 barrels per month of 19.70 API gravity crude oil. The present Royalty Oil Sales 19.70 API gravity crude oil. The present Royalty Oil Sales 19.87 and terminating on November 1, 1987. Royalty oil from these leases may be taken in kind or returned to the lessee on demand.

A Notice Inviting Bids for a new Royal Oil Sales Contract to run from November 1, 1987 to May 1, 1989 was published in the Orange County Register on August 26, 1987 and was sent to all known interested parties. Bids were received and opened on September 10, 1987. Exhibit "A" shows the results of the bidding.

Fiscal and legal reviews of the submitted bid material were done by the SLC Auditing and Legal Units respectively. Based on the results of these reviews, the highest responsible bidder was Golden West Refining Company, offering \$0.749 per barrel above the base price.
