BACKGROUND: On July 24, 1986, the State Lands Commission approved the issuance of a Master Lease to the City of Sacramento covering a portion of the Sacramento River located along the waterfront in "Old Sacramento". The Commission, as part of the approval, also authorized a sublease to the Riverboat Delta King and approved a form of agreement to be used in those cases where a sublessee wishes to use its sublease for security of a loan.

CURRENT SITUATION:

The Sublessee (Riverboat Delta King) of the City has applied to Home Federal Savings of San Diego (HOME) for a loan to reconstruct portions of the riverboat. As a condition of the loan, HOME has required that they have a security interest in the sublease to the Master Lease. The Master Lease contemplates and provides for subleasing and encumbrancing of subleases for financing purposes with State approval. Because there is an additional layer in this transaction (i.e. lease <u>and</u> sublease), some modifications to the State's standard form security agreement (Agreement and Consent to Encumbrancing of Lease) will be required and the agreement will have four (4) parties (State/Lessor, city/Lessee, Riverboat Delta King/Sublessee, Home Federal/lender) instead of the usual three(3).

OTHER PERTINENT INFORMATION:

 Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.
