SECOND MODIFICATION OF THE 1987-88
PLAN OF DEVELOPMENT, OPERATIONS AND BUDGET,
LONG BEACH UNIT, WILMINGTON OIL FIELD,
LOS ANGELES COUNTY

The City of Long Beach has requested approval of the Second Modification of the 1987-88 Plan of Development, Operations and Budget, Long Beach Unit. This Modification would change the plan to provide for an additional four months drilling rig activity primarily to allow for the redrilling of existing wells. The total adjusted budget would remain unchanged at \$132,017,000.

Recent reservoir studies, based on the reservoir modeling program now well underway, have helped define those areas and subzone intervals of several reservoirs with substantial oil reserves. In many cases, these reserves are economically recoverable at current oil prices by recompletion or redrilling of existing idle wells. Development through new wells may be justifiable in some special locations.

The actual work to be done will be selected from the most viable locations and approved under Part IV B 7 of the Plan & Budget. Proposed producing wells will be reviewed with changing oil prices to be certain adequate economic justification exists. Injection wells will be selected on the need for additional water and improved sweep efficiency.
