

TERMS OF ORIGINAL LEASE: 4 Initial period: Ten years beginning May 1, 1987 Consideration: \$100 per annum; five-year rent review. TERMS OF PROPOSED AMENDMENT: Increase acreage from 1,642 acres to 2,723 acres CONSIDERATION: \$114.62 per annum; with the State reserving the right to fix a different rental on each fifth anniversary of the lease. BASIS FOR CONSIDERATION: Pursuant to 2 Cal. Adm. Code 2003. APPLICANT STATUS: Applicant is lessee of adjacent land.

Subsequently, Bixby apparently lost interest in the leasing the area. Therefore, applicant wishes to re-include the area into his lease.
