APPROVAL OF THE SALE BY THE CITY OF LONG BEACH OF THE LIQUID PETROLEUM GAS PRODUCTS, LONG BEACH HARBOR DEPARTMENT TIDELANDS PARCEL AND PARCEL "A", WILMINGTON OIL FIELD, LOS ANGELES COUNTY

On January 21, 1988, the State Lands Commission approved the significant contract specifications for the sale of liquid petroleum gas products from the Long Beach Harbor Department Tidelands Parcel and Parcel "A", Wilmington Oil Field, Los Angeles County. At present, these products are being sold to Lomita Gasoline Company (Petrolane Gas Service Limited Partnership) under an interim sales contract for which Petrolane is paying the City a price of \$0.37 per gallon. The volume of liquids being sold is approximately 1500 gallons per day.

A Notice Inviting Bids was published in the <u>Long Beach</u> <u>Press-Telegram</u> on February 2, 3 and 4, 1983. Bids were to be received and opened on February 24, 1988.

No bids were received, so the City will continue to sell the Liquid Petroleum Gas Products to Lomita Gasoline Company (Petrolane Gas Service Limited Partnership) until February 28, 1989 when the present Cperating Agreements expire.

Pursuant to Section 10(a) of Chapter 29, Statutes of 1956, 1st E.S., any agreement for the sale or other disposition of oil, gas or other hydrocarbon derived from the Long Beach tidelands must be approved by the State Lands Commission.

OTHER PERTINENT INFORMATION: 1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has
