BACKGROUND:

Stockton Yacht Club facilities, including the club house and other improvements are located within the last natural bed of the Old Calaveras River which are claimed by the State as sovereign tide and submerged lands. Staff has contacted representatives of the Club on numerous occasions, by letter and phone, and made repeated attempts to bring the club and its facilities under lease. In the most recent contact by staff in early March, staff was informed by a club representative that the club would not enter a lease unless ordered to do so by a court.
