- The subject recreational pier was constructed in 1958 to accommodate residents of the adjacent upland trailer The Lessee was in the process of deciding whether or not to remove the pier when it sustained severe storm damage in June 1987. The Lessee requested permission to remove the pier and terminate the lease. The required permits and approvals were obtained for the pier removal. cleared site was inspected by staff of the Commission's Long Beach office, who found the removal work satisfactory. The Lessee has provided staff with an executed Lease Quitclaim Deed. Staff recommends termination of the lease, effective February 20, 1988.
- 2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
- 3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.
