AUTHORIZATION TO FILE DISCLAIMER RE:
UNITED STATES OF AMERICA v. 225.0 ACRES OF LAND,
MORE OR LESS, ET AL, UNITED STATES DISTRICT COURT,
EASTERN DISTRICT OF CALIFORNIA,
CIVIL NO. S 88-0087-EJG, TRINITY COUNTY

The State Lands Commission is a party to a United States
condemnation action brought by the United States Attorney
entitled, United States of America v. 225.0 Acres of Land, More
or Less, Etc., Et Al, filed in the United States District
Court, Eastern District of California, Civil No. S 88-0087-EJG
involving land in Trinity County to be used in connection with
the Grass Valley Creek Debris Dam.

Upon examination of the Commission's records pertinent to the
area, it has been ascertained that there is no compensable
interest held by the State Lands Commission as to the tract of
land described in the notice of condemnation.

Inasmuch as this suit involves land over which the Commission
has no compensable jurisdiction, it is recommended that a
disclaimer of compensation be filed on behalf of the State
Lands Commission disclaiming any compensable right, title, or
interest in the tract of the subject condemnation.


