AUTHORIZATION TO FILE LIMITED DISCLAIMER RE: OLCESE WATER DISTRICT U. LA HACIENDA, ET AL SUPERIOR COURT OF CALIFORNIA COUNTY OF KERN, NO.201983

The State lands Commission is a party to a condemnation action brought by the Olcese Water District entitled, Olcese Water District v. La Hacienda, Inc., et al, filed in the Superior of California, Kern County, No. 201873 involving land in Kern County to be used in connection with a water diversion project involving the Kern River.

Upon examination of the Commission's records pertinent to the area, it has been ascertained that there is no interest held by the State Lands Commission as to certain of the tracts of land described in the notice of condemnation.

Inasmuch as those parcels involve land over which the Commission has no jurisdiction, it is recommended that a limited disclaimer be filed on behalf of the State Lands Commission disclaiming any compensable interest in those parcels of the subject condemnation listed in EXHIBIT "A".
