## OTHER PERTINENT INFORMATION:

L. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 2, Replacement or Reconstruction, 14 Cal. Adm. Code 15302(c).

Authority: P.R.C. 21084 and 14 Cal. Adm. Code 15300.

- 2. GTZ California Incorporated has applied to the State Lands Commission for permission to abandon an existing submarine cable in place, and to install two buried, four-inch conduits adjacent to the existing facility, in replacement of its function. Both the abandonment and new construction is within a right-of-way covered in permit PRC 1502.
- 3. The records of the Commission disclose that the existing submarine cable permit at the subject location was originally granted to the Delta Telephone and Telegraph Company, permit No. PRC 1502, executed by the State on April 22, 1955, to run for an indefinite term, effective upon the date of document execution. That permit has never been terminated nor assigned to another party.
- 4. Effective upon the close of business, December 31, 1964. Delta Telephone and Telegraph Company was merged into General Telephone Company of California, the former name of GTE California Incorporated, which assumed all the obligations of Delta pursuant to Section 4124 of the Corporation Code of California, including the duties and obligations in permit PRC 1502. Such rights and duties in the permit inured to the Applicant by operation of law, and no action is required of the Commission in that regard.




