AUTHORIZATION TO FILE DISCLAIMER OF COMPENSATION
RE: UNITED STATES OF AMERICA V. 42.88 ACRES OF LAND,
MORE OR LESS, ET AL
UNITED STATES DISTRICT COURT, EASTERN DISTRICT
OF CALIFORNIA, CIVIL NO. 88-836 RAR EM

The State Lands Commission is a party to a United States condemnation action brought by the United States Attorney entitled, United States of America v. 42.88 Acres of Land, More or Less, Et Al, filed in the United States District Court for the Eastern District of California, Civil No. 88-836 RAR-EM, involving land in Trinity County to be used in connection with the Grass Valley Creek Debris Dam, Trinity River Division of the Central Valley Project.

Upon examination of the Commission's records pertinent to the area, it has been determined that there is no compensable interest held by the State Lands Commission as to the tract of land described in the notice of condemnation.

Since this suit involves land over which the Commission has no compensable interest, it is recommended that a disclaimer of compensation be filed with the court.

The action recommended will have no effect on public rights to recreational navigation which may exist in any waterways within the subject tract.

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt.

AUTHORIZE THE ATTORNEY GENERAL TO FILE A DISCLAIMER OF COMPENSATION OF BEHALF OF THE STATE LANDS COMMISSION IN THE CASE OF UNITED STATES OF AMERICA V. 42.88 ACRES OF LAND, MORE OR LESS, ET AL., IN THE COUNTY OF TRINITY, STATE OF CALIFORNIA ETC., ET AL., UNITED STATES DISTRICT COURT, EASTERN DISTRICT OF CALIFORNIA, CIVIL NO. 88-836 RAR-EM.


