As part of the ongoing San Joaquin River Study, and in conjunction with the Corps of Engineers clearing and snagging project, staff has been advised of many claims of private ownership within the bed of the San Joaquin River within Fresno and Madera counties.

One of the sites examined is an island lying within the low water channel of the San Joaquin River known as Goat Island. An examination of the Assessor's records of Madera County shows the Island assessed to the Federal Land Bank of Sacramento and these entities have been succeeded by the Western Farm Credit Bank which has an office in Sacramento. Staff, after reviewing the available evidence and history of Goat Island, prepared a request for a quitclaim deed, along with a title document package for the Western Farm Credit Bank to consider. The Bank as signed the quitclaim deed which is now in the possession of State Lands Commission staff.

Staff recommends acceptance of and approval to record this deed.
