A 2.286-acre parcel of tide and submerged land located at Toyon Bay, Santa Catalina Island,

Los Angeles County.

LAND USE:

Construction, operation, and maintenance of a pier, floats and swimline used in conjunction

with upland camp program.

TERMS OF ORIGINAL PERMIT:

Initial period:

Ten years beginning January 1,

1982.

Public liability insurance: Combined single

limit coverage of \$1,000,000.

Consideration:

\$50 par annum plus the public benefit; five-year rent

review.

TERMS OF PROPOSED AMENDMENT:

The amendment expands the permit area to provide for the increased length of the reconstructed pier and attendant facilities.

- 1. On January 1, 1982, the State Lands
 Commission authorized Lease PRC 6457 to
 the School of the Pacific Islands for
 educational and recreational facilities
 used in conjunction with upland camp
 program. On September 26, 1985, the
 Commission authorized an assignment of the
 lease to Guided Discoveries, Inc., dba
 Catalina Island Marine Institute (CIMI).
 Winter storms destroyed a 60-foot section
 of the pier necessitating reconstruction of
 the pier. Applicant now desires to
 reconstruct and lengthen the pier and
 floating dock, which requires amending the
 lease description to reflect the change in
 use area.
- 2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 2, Replacement or Reconstruction (pier) and, Class 3, New Construction of Small Structure (dock), 2 Cal. Code Regs. 2905(b) and 2905(c)(1).

Those parcels of tide and submerged land in Toyon-Bay on the northeasterly shore of Santa Catalina Island, Los Angeles County, California, described as follows:

PARCEL 1 - PIER AND SWIM AREA

BEGINNING at a point on the landward centerline of an existing pier having California Coordinate System Zone 7 coordinates of X = 4,180,600 and Y = 3,884,950; thence the following eight courses:

- 1. N 42° W, 18.0 feet 2. N 48° E, 348.0 feet 3. S 42° E, 18.0 feet t 18.0 feet to Point "A"; continuing
- 4. S 42° E. 18.0 feet
- 5. S 48° W, 118.0 feet
- 6. S 42° E, 768.0 feet 7. S 48° W, 230.0 feet
- 8. N 42° W, 786.0 feet to the point of beginning.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark.

PARCEL 2 - MOORING LINE ANCHORS

A 40 foot semi-circular parcel, the radius point being at the above mentioned Point "A"; said semi-circular parcel lying northeasterly of a line bearing S 42° E and passing through 'said Point "A".

PARCEL 3 - MOORING BUOYS

Six circular parcels of submerged land 40 feet in diameter lying approximately 100 feet northerly of above described Parcel 1.
