## AUTHORIZATION TO FILE A DISCLAIMER

The State Lands Commission is a party defendant to a condemnation action brought by the United States entitled <u>United States of America v 0.70 Acres of Land, More or Less, in</u> <u>the County of Kern, State of California, et al.</u>, Civil No. CV-7-88-315-REC, filed in the United States District Court, Eastern District of California. The easement in the land is being acquired by the United States in connection with the construction and maintenance of the Pacific Crest National Scenic Trail.

Upon examination of the Commission's records pertinent to the area, it was ascertained by staff that the easement to be taken crosses lands the State never acquired or disposed of. Based on this analysis, staff believes the State has no compensable interest and recommends that a disclaimer be filed with the court.




