 Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that the continued use of the boat launching ramp exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities, 2 Cal. Code Regs 2905(a)(2).

- 2. The original permit was issued to the Wildlife Conservation Board (WCB) for a period of twenty years as the operators of the County owned upland park. In late December 1988, the Humboldt County Board of Supervisors directed staff to notify the WCB that the County no longer wished the park operated by WCB but would take over operation themselves.
- The original permit to WCB was for the boat-launching ramp only. The proposed permit to the County will also include existing bank protection placed in 1986.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that the riprap bank protection is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alterations to Land, 14 Cal. Code Regs. 15304.


