**FIRST MODIFICATION OF THE 1990-91  
PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET,  
LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY**

The City of Long Beach has requested approval of the First Modification of the 1990-91 Plan of Development and Operations and Budget, Long Beach Unit. This modification will add an additional six months drilling rig activity to the Plan and augments the 1990-91 Plan and Budget in the amount of \$5,500,000.

Dear Mr. Warren:

In accordance with the provisions of Part IV, Section A, of the 1990-1991 Plan and Budget, we are submitting for your approval the First Modification of the Plan of Development and Operations and Budget of the Long Beach Unit covering the period July 1, 1990 through June 30, 1991.

The First Modification revises the Drilling and Development Program to permit the operation of a third drilling rig during the fiscal year which begins July 1, 1990. This modification augments the 1990-1991 Plan and Budget in the amount of \$5,500,000.
