RATIFY APPROVAL OF THE FOURTH MODIFICATION OF THE 1989-90
PLAN OF DEVELOPMENT, OPERATIONS AND BUDGET, LONG BEACH
UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY

The City of Long Beach has requested approval of the Fourth Modification of the 1989-90 Plan of Development, Operations and Budget, Long Beach Unit. Under the approval 1989-90 Plan and Budget, Part IV, Procedures, any transfer of funds between Program Budgets shall be accomplished by a Budget Modification in accordance Section 5(g) of Chapter 138. This Modification would modify the Plan to provide for the removal of asbestos material from field locations. The total adjusted budget would remain unchanged at \$141,377,000.

An Asbestos Field Pulk survey for all Long Beach Unit field offices, field operating facilities and marine equipment completed March 29, 1990 recommended a full abatement program to eliminate further possibility of exposure to personnel working in proximity to those areas containing asbestos contaminated materials. Under AB 3713, the field contractor has 90 days to perform full abatement of asbestos containing materials or to notify employees of the continued possibility of health hazards related to exposure of asbestos contaminated materials. The estimated cost to fund the abatement program is \$200,000. This project was not included in the current plan. There are surplus expense funds in the Oil and Gas Production Program so augmentation is not required. The State Lands Commission Executive Officer and Long Beach City Manager mutually agree to approve the Fourth Modification on May 9, 1990 under the provisions of Section 5(g), Chapter 138 and the modification is being brought before the Commission for ratification.

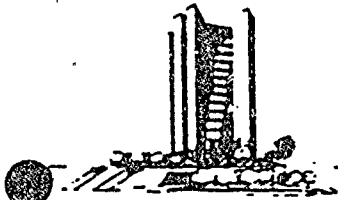


