On January 26, 1981, Minute Item 10, the State Lands Commission approved the assignment of lease PRC 4897 for the operation and maintenance of a commercial marina at Knights Landing to Jerry and Margarette Meline. The assignment became effective on June 23, 1980.

Starting in April 1981, letters were sent to Mr. or Mrs. Meline requesting annual rental payments and evidence of compliance with insurance or bond requirements. Staff received a notice of cancellation of liability insurance effective June 12, 1981. The insurance has never been replaced or renewed.

During the 'sase period, the Lessee has breached the lease contract by:

- Failure to supply the required insurance since June 12, 1981.
- Failure to pay the annual rental for the remaining five years of the lease term. Rental has not been received on this lease since 1984. Lessee owes \$1,250, \$250 for each year since January 24, 1985, plus penalty and interest.
- 3. Failure to remove all structures from the lease premises within 90 days of the lease expiration date. Lease expired on January 23, 1990.

CURRENT STATUS:

The Commission staff has diligently attempted to contact Mr. Meline for the purpose of bringing this lease into conformance, but has been unsuccessful to date.

Mr. Meline was contacted by letters dated July 29, 1987, January 13, 1988, January 27, 1988, December 7, 1989, December 22, 1989, and May 8, 1990. Staff also called Mr. Meline on the telephone on November 12, 1987. He was not available and did not return the call as requested.

Mr. Meline has been advised that this lease expired on January 23, 1990. On December 22, 1989, a final letter was sent requesting his cooperation in this matter. To date, there has been no response.






