AUTHORIZE ISSUANCE OF FIVE (5) RECREATIONAL PIER PERMITS

APPLICANT: As listed on Exhibit "A" attached

AREA, TYPE LAND AND LOCATION:

A .317-acre parcel of sovereign tide and submerged land located in the Huntington Harbour Main Channel, City of Huntington Beach, Orange County.

LAND USE:

Use and maintenance of five boat docks for private recreational use.

TERMS:

Initial period: Ten years beginning August 22, 1990.

Renewal options: None.

Filing fee: \$25 (each).

Processing fee: \$45 (each).

CONSIDERATION: No monetary consideration pursuant to Section 6503, P.R.C.

PREREQUISITE TERMS:

Applicants are littoral landowners as defined in Section 6503, P.R.C.

BACKGROUND INFORMATION:

Southwest Savings and Loan has sold the property upland of the lease premises to Scothill Corporation, effective June 10, 1988. Scothill subsequently sold the upland to five new owners for development of private residences, effective June 11, 1988.

State Lands Commission issued a ten- (10) year permit for docking facilities to Southwest Savings and Loan in 1980. That permit was never assigned to the intervening upland owner (Scothill) and has expired. The intervening owner has since subdivided the upland into five (5) lots and they have been purchased by separate individuals. The five (5) lots are now developed with single-family residences.

All applicants have submitted applications for individual recreational pier permits, paid filing and processing fees, provided grant deeds for the new subdivided lots, and have signed recreational pier permits. Based on the fact that this is a newly subdivided area with single-family residences, each homeowner qualifies for a rent-free recreational pier permit instead of a general permit for recreational use.

OTHER PERTINENT INFORMATION:

1. As to the issuance of five new recreational pier permits for the existing piers, pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities, 2 Cal. Code Regs. 2905(a)(2).

Authority: P.R.C. 21084, 14 Cal. Code Regs. 15300, and 2 Cal. Code Regs. 2905.

2. This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. However, the Commission has declared that all tide and submerged lands are "significant" by nature of their public ownership (as opposed to "environmental significant"). Since such declaration of significance is not based

upon the requirements and criteria of P.R.C. 5370, et seq., use classifications for such lands have not been designated. Therefore, the finding of the project's consistency with the use classification as required by 2 Cal. Code Regs. 2954 is not applicable.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 1, EXISTING FACILITIES, 2 CAL. CODE REGS. 2905(a)(2).
2. AUTHORIZE THE ISSUANCE OF TEN-YEAR RECREATIONAL PIER PERMITS, BEGINNING AUGUST 22, 1990, TO THE APPLICANTS LISTED IN EXHIBIT "A", ATTACHED AND BY REFERENCE MADE A PART HEREOF.

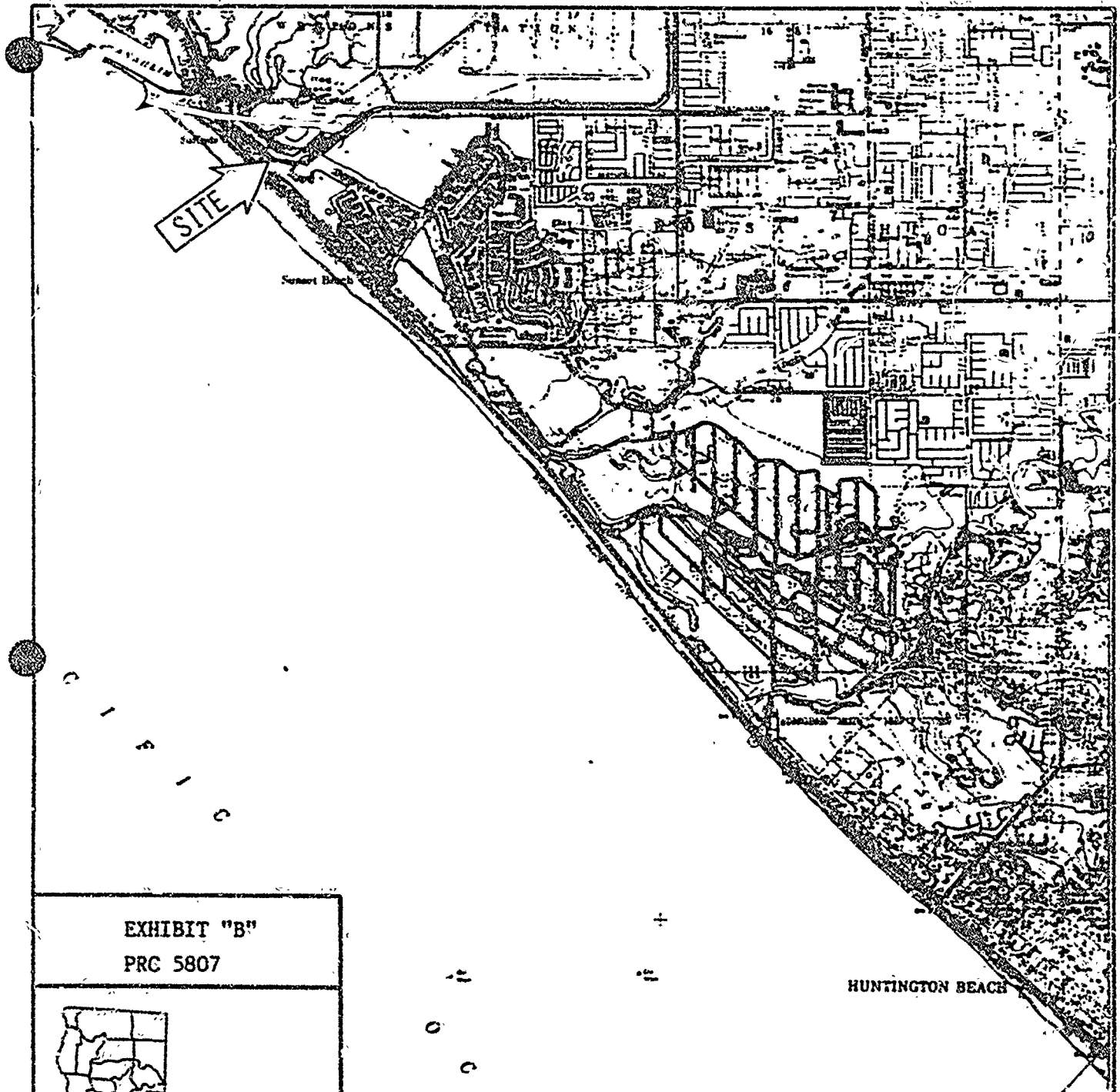
