ASSIGNMENT OF GENERAL LEASE - AGRICULTURAL USE

APPLICANT: Steven L. White, Robert Witt, Sam Perricone,
Thomas Kimmel

AREA, TYPE LAND AND LOCATION:
A 38.7-acre parcel of State school land near
Fallbrook, San Diego County.

LAND USE: Avocado production.

TERMS OF EXISTING LEASE:

Initial period: Twenty-five (25) years
beginning April 1, 1977.

Renewal options: One successive period of ten
(10) years.

Public liability insurance: \$300,000 per
occurrence for bodily injury
and \$50,000 for property
damage.

Consideration: \$11,400 per annum, or
percentage of gross revenue,
based on market price per
pound and total production,
whichever is greater;
five-year rent review.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: P.R.C. 21065 and 14 Cal. Code Regs. 15378.

2. The subject lease was approved on March 31, 1977 to Steven L. White, for a period of 25 years for avocado production. The lease was subsequently assigned to Steven L. White, Robert Witt, Sam Perricone, and Thomas Kimmel on November 29, 1984. Currently, the lessees have reorganized and request the lease be assigned to BSTCO, a partnership.

3. Lease rental is current through March 31, 1991.
