AREA, TYPE LAND AND LOCATION:
A 0.078-acre parcel of tide and submerged land
in the Sacramento River, Sacramento County.

LAND USE: Recreational floating boat dock.

TERMS OF EXISTING PERMIT:

Initial period: Ten years beginning
September 1, 1984.

Public liability insurance: Combined single
limit coverage of \$100,000.

Consideration: \$237.44 per annum; five-year
rent review.

APPLICANT STATUS:

Applicant is owner of upland.

PREREQUISITE CONDITIONS, FEES, AND EXPENSES:

Filing fee and processing costs have been
received.

Authority: P.R.C. 21065 and 14 Cal. Code Regs. 15378.

2. The proposed Assignee acquired title to the adjacent upland property, APN 132-0120-002, by a grant deed recorded December 28, 1989, in Sacramento County. The staff therefore recommends that the requested assignment be effective as of that date.

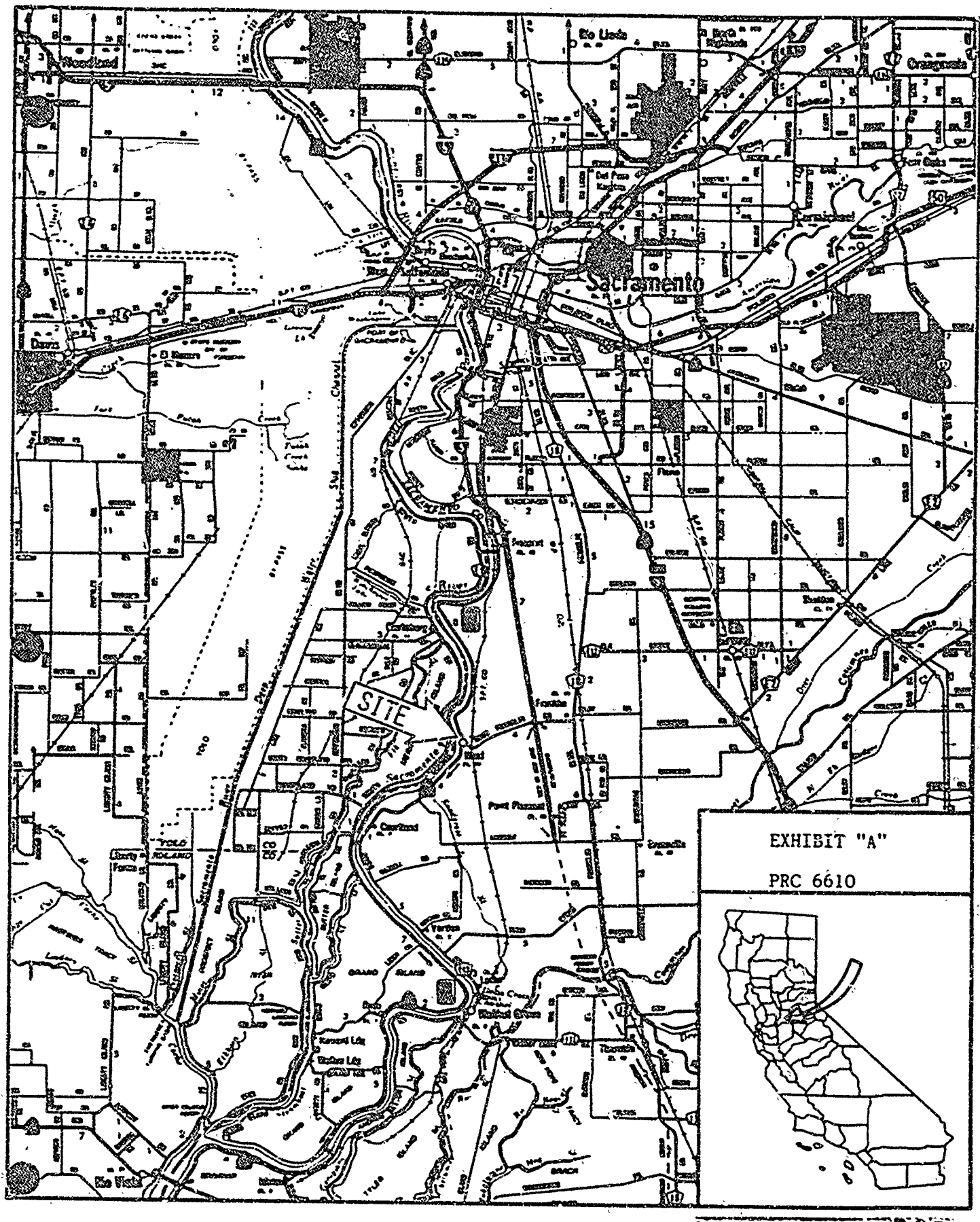
