RATIFY AWARD OF CONTRACT TO THE LOWEST BIDDER
FOR AN ENVIRONMENTAL IMPACT REPORT (EIR)
ON THE LEASING OF STATE LANDS FOR
GEOTHERMAL EXPLORATION, DEVELOPMENT, AND PRODUCTION

BACKGROUND:

The State Lands Commission (SLC), as Lead Agency under the California Environmental Quality Act (CEQA), is proposing to lease for geothermal exploration, development, and production, previously leased State lands in the Geysers Area, Lake, Mendocino, and Sonoma counties. Prior to undertaking this leasing, an EIR, pursuant to the requirement of CEQA, must be prepared. The EIR shall consider the environmental effects which may result from the leasing activities. As such, the EIR must consider the environmental impacts from geothermal exploration, development, and production.

REQUEST FOR RATIFICATION:

The Request for Proposals was issued on May 9, 1990, bids were received on May 30, 1990, and the evaluation of the proposals was completed and the Notice of Intent to Award was issued on June 7, 1990. Department of General Services Legal Office approved the contract on July 6, 1990.
