RECEIPT OF A "NOTICE OF PROPOSED USE OF  
STATE LANDS" PROVIDED FOR BY THE MEMORANDUM OF UNDERSTANDING  
BETWEEN THE DEPARTMENT OF WATER RESOURCES AND  
THE STATE LANDS COMMISSION

BACKGROUND:

On September 26, 1979, the State Lands Commission approved a Memorandum of Understanding, effective October 19, 1979, between the Department of Water Resources and State Lands Commission. It provides for use of State lands for either the Central Valley Project or the State Water Resources Development System. Under the Memorandum of Understanding, the Department of Water Resources provides State Lands Commission with a "Notice of Proposed Use of State Lands".

CURRENT SITUATION:

Based on the Memorandum of Understanding, the Department of Water Resources (DWR) has submitted a "Notice of Proposed Use of State Lands" to Commission staff, advising of their intent to install and service a tide-stage recorder on the edge of Cordelia Slough Tule Berm, Solano County. This project will be a part of the State Water Resources Development System. Staff has reviewed the plan and determined that no restrictions or limitations are needed from the State Lands Commission. The facility is exempt under CEQA 15306 (Basic Data Collection with No Serious/Major Disturbance to an Environmental Resource).

**LAND DESCRIPTION**

A parcel of tide and submerged land in the State owned bed of Cordelia Slough, Solano County, California, said parcel lying immediately beneath and extending 10 feet from the extremities of the salinity and tide stage recording facilities (S-97), said parcel having geographic coordinates. Longitude 122° 06' 46" W, and Latitude 38° 09' 26" N.

EXCEPTING THEREFROM any portion of land lying landward of the ordinary high water mark of Cordelia Slough.

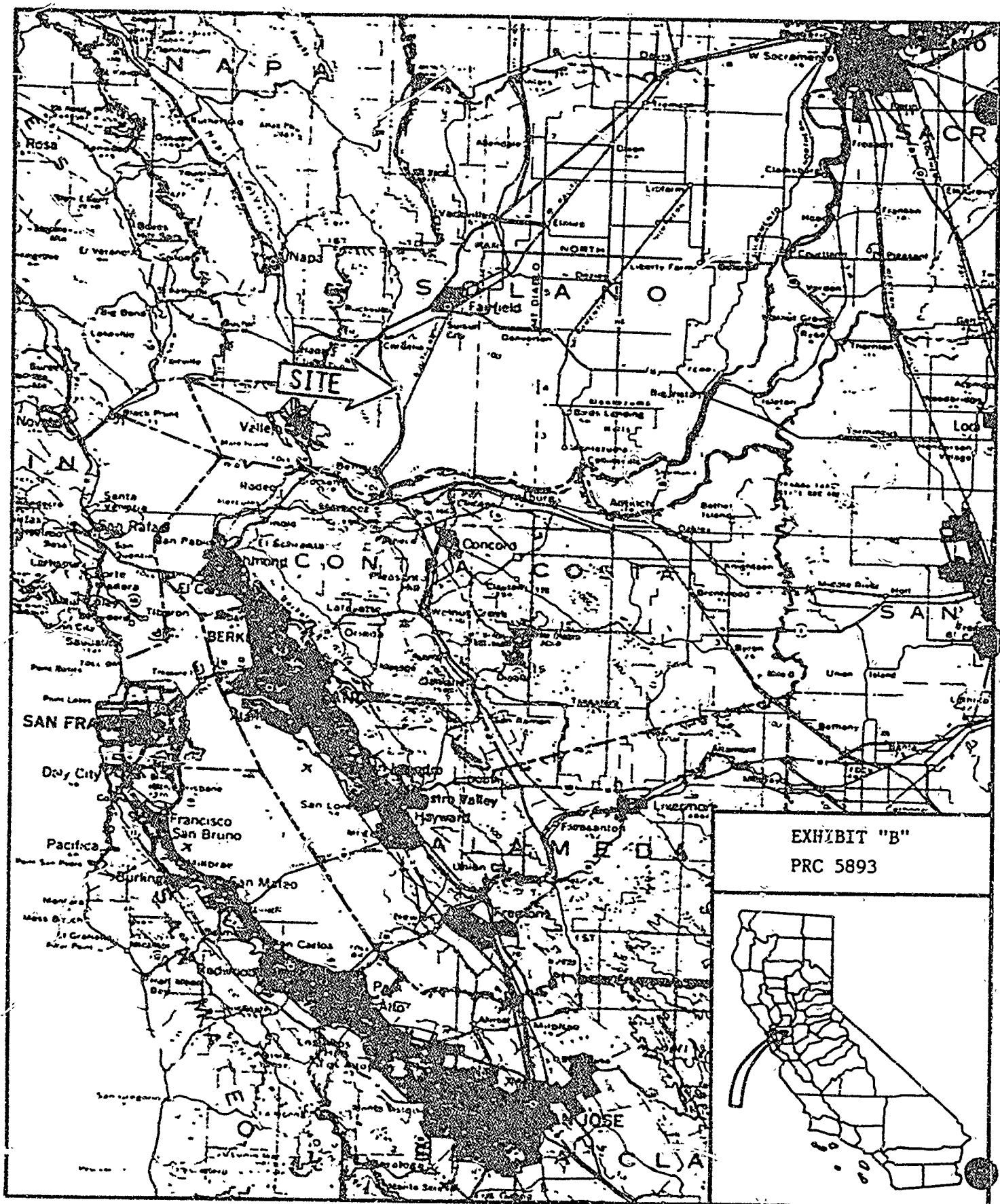
