A 0.263-acre parcel of tide and submerged land,

**LAND USE:**

Boat dock, ramp, riprap.

**TERMS OF ORIGINAL PERMIT\*:**

Initial period: Ten years beginning August 1,  
1985.

Public liability insurance: Combined single  
limit coverage of \$100,000.

Consideration: The public use and benefit  
with the State reserving the  
right at any time to set a  
monetary rental for the  
riprap if the Commission  
finds such action to be in  
the State's best interest.  
Dock is rent-free pursuant to  
P.R.C. 6503.5, et seq.

**OTHER PERTINENT INFORMATION:**

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: P.R.C. 21065 and 14 Cal. Code Regs. 15378.

2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

3. The Applicant and staff have agreed that the proposed assignment is to be effective as of December 22, 1988 and is so recommended to the Commission.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 BECAUSE THE ACTIVITY IS NOT A PROJECT AS DEFINED BY P.R.C. 21065 AND 14 CAL. CODE REGS. 15378.
2. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.
3. AUTHORIZE THE ASSIGNMENT OF LEASE PRC 6884, EFFECTIVE DECEMBER 22, 1988, FROM RANDALL K. SCOTT, ASSIGNOR, TO JOHN CORCORAN III AND CAROL A. CORCORAN, ASSIGNEE, ALL OTHER TERMS AND CONDITIONS OF THE LEASE TO REMAIN THE SAME.

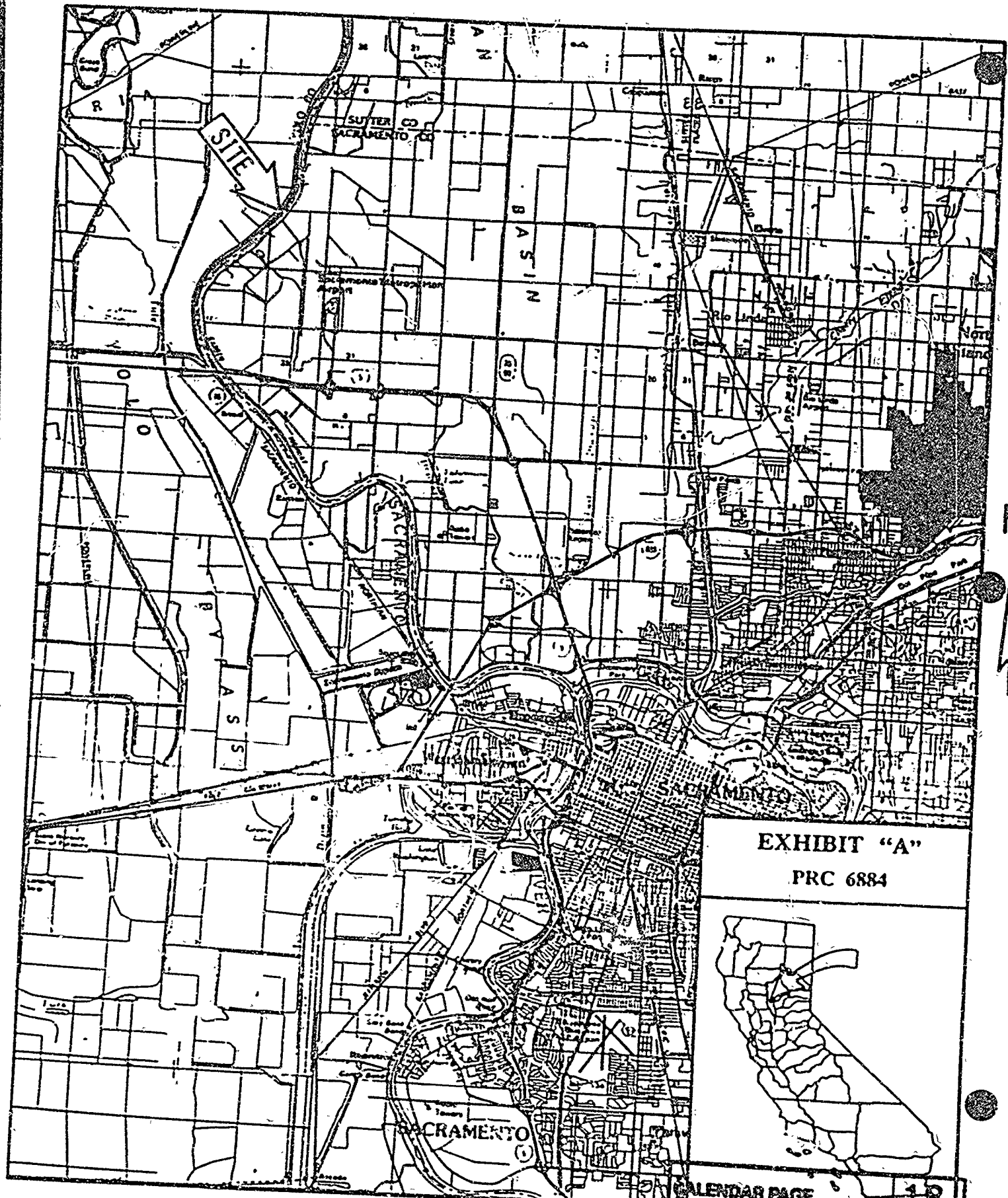
