BACKGROUND:

At its meeting of January 8, 1992, Calendar Item C03, the Commission authorized an amendment to Pacific Gas and Electric's (PG&E) master lease PRC 5438, Addendum No. 12. The amendment authorized PG&E to add two parcels of sovereign land to the master lease for the installation, operation, and maintenance of a 42-inch-diameter natural gas pipeline. The lands are located in the bed of the Sacramento River, Tehama County, and the bed of the Fall River in Shasta County.

The exhibits submitted with Calendar Item C03 for the Sacramento River crossing, exhibits A-97 and B-97, were submitted with the incorrect description and location map.

Commission staff has revised the exhibits, as attached hereto, and incorporated them within Addendum 12 of master lease PRC 5438. The revised exhibits describe and depict the correct location where the authorized improvements, when installed by PG&E, will be located on the Sacramento River, Tehama County.



Sacramento River

LAND DESCRIPTION

A strip of submerged land 100 feet wide lying in the bed of the Sacramento River, in protracted Section 35, T27N, R3W, MDM, and in Rancho Rio De Los Berrendos, in Tehama County, California, and being 50 feet on each side of the following described centerline:

COMMENCING at a 1 1/2" galvanized iron pipe U.S.C.E. MI241.8L having California State Plane Coordinate System, Zone 1 coordinates Y=299214.92; X=1950281.25, NAD 27; thence S 75° 30' W, 148 feet to the TRUE POINT OF BEGINNING of said parcel centerline, said point being located on the northerly side of the Sacramento River, and also being located 82 feet westerly of an existing Pacific Gas & Electric Company pipeline; thence continuing S 10° 50' W, 1400 feet to the terminus of said centerline, said terminus being located on the southerly side of the Sacramento River, and also being located 76 feet westerly of said existing pipeline.

EXCEPTING THEREFROM any portion lying landward and northerly of the northerly low water mark; and any portion lying landward and southerly of the southerly low water mark of the Sacramento River.


