## OTEER PERTINENT IMFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a statutorily exempt project. The project is exempt because it involves an action taken pursuant to the School Land Bank Act, P.R.C. 8700, et seq.

Authority: P.R.C. 8710.

2. In 1984, the Morongo Basin Joint Powers Authority was formed to provide support and guidance to meet future demands for water. After multiple studies, it has been deemed imperative that a water pipeline, from the state aqueduct near Hesperia to the Morongo Basin, be constructed to insure a dependable water supply. Funding for the project is from a $\$ 66.5$ million bond issue approved by the voters in 1990.
3. The consideration of $\$ 16,700$ will be deposited in the School Land Bank Fund to facilitate the management of school lands for the purpose of generating revenue and carrying out the goals of the School Land Bank-Act. The State Lands Commission will be acting as trustee for the School Land Bank Fund pursuant to Division 7.7 of the P.R.C.
4. An appraisal to determine value of the parcel was prepared, reviewed, and approved by Commission staff.
5. Staff has filed a general plan for this activity with the Legislature pursuant to P.R.C. 6373.

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 ÁS A STATUTORILY EXEMPT PROJECT PURSUANT TO P.R.C. 8710, AN ACTION TAKEN PURSUANT TO THE SCHOOL LAND BANK ACT, P.R.C 8700, ET SEQ.

4. AUTHORIZE THE DEPOSIT OF $\$ 16,700$ IN THE SCHOOL LAND BANK FUND FOR THE SALE OF LANDS TO FACILITATE THE MANAGEMENT OF SCHOOL LANDS FOR THE PURPOSE OF GENERATING REVENUE AND CARRYING OUT THE GOALS OF THE SCHOOL LAND BANK ACT.


## LAND DESCRIPTION

Those ten (10) parcels of State-owned lands in San Bernardino County, California, more particularly described as follows:

A strip of land, 40.00 feet wide, over that portion of the North $1 / 2$ of the Northeast $1 / 4$ and the North $1 / 2$ of the Southeast $1 / 4$ of the Northeast $1 / 4$ of Section 21 , Township 4 North, Range 2 East, San Bernardino Base and Meridian, in the County of San Bernardino, State of California, according to the official plat of said land filed in the District Land Office, lying 40 feet southwesterly of the following described northeasterly line:

Said strip of land shall be prolonged or shortened to terminate in the west and south lines of the North $1 / 2$ of the Northeast $1 / 4$ and in the west and south south lines of the North $1 / 2$ of the Southeast $1 / 4$ of the Northeast $1 / 4$ of said Section 21.

Said strip of land shall be prolonged or shortened to terminate in the west and east lines of the Southeast $1 / 4$ of said Section 22.

COMMENCING at the West $1 / 4$ corner of said Section 23; thence South $00^{\circ} 31^{\prime} 32^{\prime \prime}$ East, 698.21 feet along the West line of said South $1 / 2$ to the TRUE POINT OF BEGINNING; thence, leaving said West line South $83^{\circ} 24^{\prime \prime} 40^{\prime \prime}$ East, 617.36 feet; thence South $83^{\circ} 21^{\prime} 40^{\prime \prime}$ East, 1460.20 feet; thence South $83^{\circ} 19^{\prime} 40^{\prime \prime}$ East, 1394.34 feet; thence South $78^{\circ} 52^{\prime} 0^{\prime \prime}$ East, 1584.32 feet to the beginning of a tangent curve, concave Southerly and having a radius of 2000.00 feet; thence Easterly 163.58 . feet along said curve through a central angle of $04^{\circ} 41^{\prime} 10^{\prime \prime}$; thence tangent to said curve South $74^{\circ} 10^{\prime} 41^{\prime \prime}$ East, 145.95 feet to a point on the East line of said Section 23, said point being distant South $00^{\circ} 37^{\prime} 03^{\prime \prime}$ East, 1566.69 feet along said East line from the East $1 / 4$ corner of said Section 23 and being the terminus point of said strip of land: The sidelines of said strip of land shall be prolonged or shortened to commence at the West line and to terminate at the East line of said Section 23.
EXCEPTING THEREFROM those portions lying within the Southwest $1 / 4$ of said Section 23, and the South $1 / 2$ of the Southeast $1 / 4$ of said Section 23.

## PARCEL 4

Said strip of land shall be prolonged or shortened to terminate in the west line of the Southeast $1 / 4$ of said Section 24 and in the west and south lines of the Northeast $1 / 4$ of said Section 25.

Said strip of land shall be prolonged or shortened to terminate in the west and east lines of said Fractional Section 32.

## PARCEL 8

A strip of land, 40.00 feet wide, over that portion of Section 33, Township 4 North, Range 3 East, San Bernardino Base and Meridian, in the County of San Bernardino, State of California, according to the official plat of said land filed in the District Land Office, lying southerly of the following described northeasterly line:

Commencing at the Northwest comer of said Section 33; thence South $00^{\circ} 53^{\prime} 01$ " East, 865.11 feet along the west line of said Section to a point on a non-tangent curve, concave southwesterly and having a radius of 3000.00 feet, a radial line of said curve to said point bears North $43^{\circ} 17^{\prime} 59^{\prime \prime}$ East, said point also being the TRUE POINT OF BEGINNING; thence Southeasterly 187.20 feet along said curve through a central

Said strip of land shall be prolonged or shortened to terminate in the west line of said Section 3 and east line of said Section 10.

## GENERAL PLAN

The State Lands Commission proposes to sell $33.40 \pm$ acres of State School land to the Mojave Water Agency.

The Mojave Water Agency is acquiring approximately 70 miles of pipeline right of way in San Bernardino County for the Morongo Basin Water Pipeline Project. The right of way is divided into a number of ownerships including the federal government, the State of California and private landholders. The proposed alignment primarily parallels existing road rights of way. The acquisition will facilitate the construction and operation of a water pipeline to deliver State project water from the State water aqueduct near Hesperia to the Morongo Basin.
